RE: OLD POST OFFICE MUSEUM

PURSUANT TO Subsection (6) of Section 29 of The Ontario Heritage Act, 1974;

TAKE NOTICE THAT Oakville Town Council, by by-law, on February 6th, 1978, did designate a certain property as a property of historic and architectural value and interest. The by-law is detailed below, together with an explanation of the reasons for the designation:

THE CORPORATION OF THE TOWN OF OAKVILLE

BY-LAW NUMBER 1978-7

A by-law to designate certain property as property of historic and architectural value and interest (Old Post Office Museum).

THE COUNCIL ENACTS AS FOLLOWS:

1. The property commonly known and referred to as the Old Post Office Museum is hereby designated as a property of historic and architectural value and interest pursuant to The Ontario Heritage Act, 1974/
2. The property designated by this by-law is the property described in Schedule "A" to this by-law.
3. The designation affects only as much of the lot as is covered by the Old Post Office Museum.

SCHEDULE "A" to By-law Number 1978-7

ALL AND SINGULAR that certain parcel or tract of land situate, lying and being in the Town of Oakville, in the Regional Municipality of Halton and being composed of Lot B, Block 77 according to the original plan for the Town of Oakville (now commonly referred to as Plan 1) registered in the Land Registry Office for the Land Registry Division of Halton.

REASONS FOR DESIGNATION

The Old Post Office Museum is a well preserved example of a typical small wood frame building, which succeeded the Log House; a style the Loyalists continued to use upon settling in Canada. It was built in 1835 as Oakville's first Post Office and Colonel William Chisholm was appointed its first Postmaster at that time. The building originally stood on Colborne Street, (Lakeshore Road), west of Navy Street, and was relocated to its present site in 1950, as a museum. In 1953, the owners conveyed the structure as a gift to the Town of Oakville. It is now being administered and maintained by the Oakville Historical Society.




