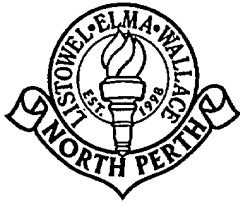



Enclosed please find a copy of a *Notice Of Intention To Pass A By-law*, to amend the heritage designation by the former Town of Listowel under By-law No. 91-15. This By-law designated the entire property owned at the time by the Listowel Public Utilities Commission. The new Town of North Perth recently sold a transformer site on the property to Hydro One Inc. This sales does not include The Pumphouse and the heritage designation remains on this portion of the property.

*TAKE NOTICE that the Council of the Corporation of the Town of North Perth intends to pass By-law No. 83-AD-2001, to amend the designation of the following property as being of architectural and historical value or interest under Part IV of The Ontario Heritage Act, R.S.O. 1990, Chapter 0.18*

*580 Main Street West, Listowel Ward, Town of North Perth  
The building known as  
the "Pumphouse" is a rare example of the turn of  
the century industrial/municipal architecture, and remove only  
the portion of the property on which the transformer is situated,  
which is being sold to Hydro One Inc.*

*NOTICE OF OBJECTION to the repealing of this section of the heritage designation may be served on the Clerk within thirty (30) days of the date of the publication of this Notice of Intention.*
