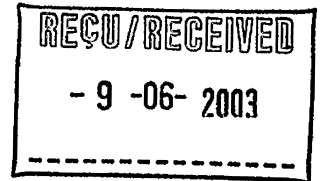

TAKE NOTICE that the Council of the Corporation of the Township of North Grenville intends to designate the property, including lands and buildings, at the following municipal address as a property of architectural and historical value or interest under Part IV of the *Ontario Heritage Act, R.S.O., 1990*.

**MUNICIPAL ADDRESS**

313 French Settlement Road, Township of North Grenville (former Township of South Gower).

**REASONS FOR PROPOSED DESIGNATION**

The building located at 313 French Settlement Road is recommended for designation as being of architectural and historical value. The full particulars of the Reasons for Designation are available in the Clerk's office at the Municipal Building, 275 County Road 44 from 8:30 a.m. until 5:00 p.m. Monday to Friday.

Any person, within thirty days of the first publication of this notice may send, by registered mail or deliver to the Clerk of the Township of North Grenville, notice of his or her objection to the proposed designation together with a statement of the reasons for the objection and all relevant facts. If such a Notice of Objection is received, the Council of the Corporation of the Township of North Grenville shall refer the matter to the Conservation Review Board for a hearing.
