#### NOTICE OF DESIGNATING BY-LAW

TAKE NOTICE that the Council of The Corporation of the City of Ottawa on the 20th day of February, 1980, enacted By-law Number 63-80 designating the lands and buildings known municipally as 204-210 St. Patrick Street as a property of historic and architectural value or interest under The Ontario Heritage Act, 1974, Statutes of Ontario, Chapter 122, as amended.

STATEMENT OF REASONS FOR THE DESIGNATION:

Residence Brousseau, the four unit brick veneer row house at 204-210 St. Patrick Street, is recommended for designation as being of architectural and historical interest. Constructed in 1898 for Evangeliste Brousseau on the site of a former hotel, this Victorian two-storey structure features a flat roof with decorative cornice and soffit, a carriageway, terracotta patterns on the front facade, and intricately detailed projecting balconies, a Franch-Canadian design tradition. In its overall exterior appearance, the building is an excellent example of late Nineteenth Century investment property in Lowertown, having been used as a multiple dwelling from 1898 to the present.

### BY-LAW NUMBER . 63-80 ...

A by-law of The Corporation of the City of Ottawa to designate 204-210 St. Patrick Street to be of historic and architectural value or interest;

WHEREAS The Ontario Heritage Act, 1974, Statutes of Ontario, 1974, Chapter 122, as amended, authorizes the Council of a municipality to enact by-laws to designate real property, including all the buildings and structures thereon, to be of historic and architectural value or interest;

AND WHEREAS the Council of The Corporation of the City of Ottawa has caused to be served upon the owners of the lands and premises known as 204-210 St. Patrick Street more particularly described in Schedule "A" hereto, and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in The Ottawa Journal newspaper having a general circulation in the City of Ottawa, once a week for three consecutive weeks, namely on August 25, 1979, September 1, 1979 & September 8, 1979 ;

AND WHEREAS the reasons for the designation are set out as Schedule "B" hereto;

AND WHEREAS no notice of objection to the said proposed designation has been served upon the Clerk of the City of Ottawa;

THEREFORE the Council of The Corporation of the City of Ottawa enacts as follows:-

1. There is designated as being of historic and architectural value or interest the real property, more particularly described in Schedule "A" hereto, known as 204-210 St. Patrick Street

2. The City Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" hereto in the proper Land Registry Office.

3. The City Clerk is hereby authorized to cause a copy of this by-law to be served upon the owner of the property described in Schedule "A", and upon the Ontario Heritage Foundation, and to cause notice of this by-law to be published in a newspaper having a general circulation in the City of Ottawa.

4. The Schedules attached hereto and marked Schedule "A" and Schedule "B" form part of this by-law and all notations, references and other information contained therein shall be as much a part of this by-law as if all the matters and information set forth by the said schedules were all fully described herein.
