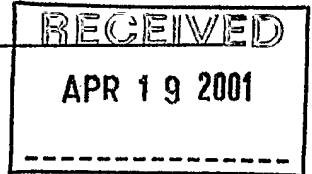



The Heritage Advisory Committee on March 5, 2001, considered the above captioned matter and recommended the following:

HAC-0011-2001 That the heritage designation By-law 482-97 with respect to the St. Ilija Macedonian Orthodox Church, 1775 Bristol Road West (formerly St. Joseph Roman Catholic Church) be repealed due to the earlier demolition of the heritage structure after its being destroyed by fire.

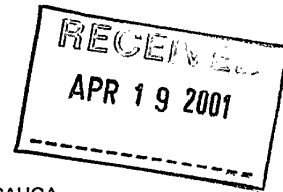

THE CORPORATION OF THE CITY OF MISSISSAUGA

BY-LAW NUMBER 0172-2001

A by-law to repeal By-law 482-97, a by-law to designate the property located at 1775 Bristol Road West as being of historic and architectural value

WHEREAS the Council of The Corporation of the City of Mississauga enacted By-law 482-97 on the 15th day of October, 1997, designating the lands and buildings located at 1775 Bristol Road West, as a property being of historic and architectural value under the Ontario Heritage Act;

AND WHEREAS the lands being the subject matter of By-law 482-97 were described as being composed of part of Lot 3, Concession 4, West of Hurontario Street of the said Township of Toronto, County of Peel, designated as Parts 7 and 10 on a plan of survey deposited in the Land Registry Office for the Land Titles Division of Peel (No. 43) as Plan 43R-13900 and are municipally known as 1775 Bristol Road West in the City of Mississauga;

AND WHEREAS on April 29, 2000, the structure at 1775 Bristol Road West was destroyed by fire;

AND WHEREAS the owner of 1775 Bristol Road West has requested approval of the Council of The Corporation of the City of Mississauga, to remove the heritage designation on this property;


NOW THEREFORE the Council of The Corporation of the City of Mississauga ENACTS as follows:

1. That By-law 482-97, a by-law to designate the property located at 1775 Bristol Road West, in the City of Mississauga, as being of historic and architectural value, is hereby repealed.
2. That the City Clerk is directed to delete any reference to the property located at 1775 Bristol Road West, in the City of Mississauga from the Heritage Register of designated properties.
3. That the City Clerk is hereby authorized to cause a copy of this by-law to be served upon the owner of the property at 1775 Bristol Road West, and upon the Ontario Heritage Foundation, and to cause notice of this by-law to be published in a newspaper having general circulation in the City of Mississauga.

4. That the Office of the City Solicitor is hereby directed to register a copy of this by-law against the property located at 1775 Bristol Road West in the proper land registry office.
