
Enclosed herewith is a notice of intention to designate a property in the Village of Wellington, described as 290 Main Street, Lot 26, Plan 8.

TAKE NOTICE that the Council of the Corporation of the County of Prince Edward intends to designate the property, including lands and buildings, at the following municipal address as a property of architectural and historical interest under Part IV of The Ontario Heritage Act, 1974, S. O. Chapter 122

(a) 290 Main Street, Lot 26, Plan 8, Village of Wellington.


The Wellington Community Historical Museum located at 290 Main Street - lot 26, plan 8 - in the Village of Wellington.

This building is the last remaining Quaker Meeting House (Society of Friends) of the original six, which were built in Prince Edward County.

This building served the Village and surrounding area from 1885 to 1966 as a Meeting House. It is of brick construction with Gothic type windows, and a fan light window over the double entrance doors.

Notice of objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts may be served on the Clerk of the County of Prince Edward before the 31st day of January, 1982.
