COUNTY OF PRINCE EDWARD
BY-LAW NO. 1500

A BY-LAW TO DESIGNATE THE PROPERTY KNOWN MUNICIPALLY AS
290 MAIN STREET, WELLINGTON, ONTARIO AS BEING OF HISTORICAL
VALUE AND INTEREST.

WHEREAS Section 29 of the Ontario Heritage Act, Chapter 337
R.S.O. 1980 authorizes the Council of a municipality to enact
by-laws to designate real property, including all buildings
and structures thereon, to be of architectural or historical
interest and value.


WHEREAS the Council of the Corporation of the County of Prince
Edward has caused to be served on the owners of the lands
and premises known as Wellington Community Historical Museum,
lot 26, plan 8 of the Village of Wellington, Wellington, Ontario
and upon the Ontario Heritage Foundation, notice of intention
to so designate the aforesaid real property and has caused
such notice of intention to be published in a newspaper having
general circulation in the municipality once for 3 consecutive
weeks and;


WHEREAS no notice of objection to the proposed designation has
been served on the Clerk of the municipality.

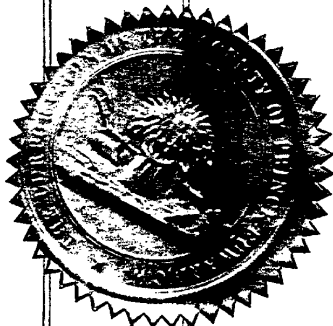
THEREFORE THE CORPORATION OF THE COUNTY OF PRINCE EDWARD
enacts as follows:

1. There shall be designated as being of historical value
and interest the real property known as "The Wellington Community
Historical Museum" at 290 Main Street, Wellington, Ontario,
being lot 26, plan 8 of the Village of Wellington.
2. The County Clerk is hereby authorized to cause a copy of
this by-law to be registered against the property described
in Schedule "A" hereto attached.
3. The Clerk is hereby authorized to cause a copy of this
by-law to be served on the owner of the aforesaid property and
on the Ontario Heritage Foundation and to cause a notice of
the passing of this by-law to be published in a newspaper
having general circulation in the municipality once for each
of three consecutive weeks.

READ A THIRD TIME AND FINALLY PASSED at Picton, Ontario this
16th day of February, 1982.

SCHEDULE "A"

ALL AND SINGULAR THAT certain parcel or tract of land and premises situate, lying and being in the Village of Wellington in the County of Prince Edward and being composed of Lot 26 and part of Lot 27 according to Donevan & Smith's Registered Plan No. 8 for the Village of Wellington, which said parcel may be more particularly described as follows:

COMMENCING where an iron bar is planted in the northerly limit of Main Street distant 132 feet 5 5/8 inches on a bearing of south 85 degrees 41 minutes west from the intersection of the north limit of Main Street and the west limit of Wharf Street in said Village;

THENCE continuing south 85 degrees 41 minutes west a distance of 60 feet 8 5/8 inches to an iron bar planted in the north limit of Main Street;

THENCE north 5 degrees 36 minutes west a distance of 164 feet 10 1/4 inches to an iron bar planted;

THENCE north 85 degrees 41 minutes east a distance of 71 feet 9 3/8 inches to an iron bar planted;

THENCE south 1 degree 46 minutes east a distance of 165.0 feet to the place of beginning.
